

7. TEMPORARY VISIT FOR TOURISM PURPOSES (ONLY WITH ERF5)

[Definition] A foreign citizen traveling to Japan for tourism (less than 90 days stay) with a travel agency organizing the trip to serve as the receiving organization of the entrants.

[Term of Stay] Stay of up to 90 days

[Validity of Visa] Single entry: 3 months from date of issue

VALID PASSPORT:

Please provide original passport, sign your passport, and check that you have at least one blank visa page.

The applicant must complete the application by typing or with black pen. **Signatures must be in ink pen.** No digital signatures will be accepted. If a field is not applicable, please write "N/A" or "None". **Please make sure to verify your email address and phone number are clearly and legibly listed on the application form.**

ONE PASSPORT SIZE PHOTOGRAPH

2X1.4 inch photograph on glossy photo paper must be taken within the last six months with plain background.

CERTIFICATE FOR COMPLETION OF REGISTRATION TO THE ERF5 SYSTEM (受付済証)
