1:30pm - 3:30pm MONDAY, WEDNESDAY, and FRIDAY only

(There will be NO morning visa applications and NO morning visa pick-ups, effective August 5th, 2020)

In general, visas are **NOT** being issued unless it is an **emergency/special circumstance due to the travel ban.**

Please note the following:

- 1. Transit, Tourism, Work, and Student visa applications are **NOT** accepted at this time.
- 2. Family emergency short-term stay visa: Please call 213-617-6700 to verify necessary documents.
- Long-term stay visa: Those with a Certificate of Eligibility under the category of "Spouse or Child of
 Japanese National," with a special circumstance, may apply for a long-term stay visa. Please call 213617-6700 to verify necessary documents.
- 4. For other special circumstances, please call 213-617-6700 and ask for the Visa Section.

Revised Processing Times

All visa applications will take approximately 4-5 business days to process. There will be NO expedited services for any applications. Applicants from remote areas are advised to provide a prepaid return envelope and a release of liability.
